PLEASE TAKE NOTICE that on July 12, 2023 at 10:00 a.m. (Pacific Time) (the "Hearing"), the Honorable Sandra R. Klein, United States Bankruptcy Judge for the Central District of California, will hold a hearing on the Debtors' Notice of Motion and Motion for an Order (I) Authorizing the Debtors to Retain and Compensate Professionals Utilized in the Ordinary Course of Business, and (II) Granting Related Relief [Docket No. 385] (the "Motion"), filed by the above-captioned debtors and debtors in possession (collectively, the "<u>Debtors</u>").

PLEASE TAKE FURTHER NOTICE that pursuant to the Motion, the Debtors seek entry of an Order approving certain procedures by which the Debtors may be authorized to retain and compensate various attorneys, accountants, consultants, and other professionals (collectively, the "OCPs," and each individually, an "OCP") for services in matters arising in the ordinary course of the Debtors' business that are unrelated to these chapter 11 cases. Because the OCPs will not be involved in administering these chapter 11 cases, the Debtors do not believe that the OCPs are "professionals" within the meaning of section 327 of the Bankruptcy Code, whose retention must be approved by the Court. The Debtors therefore submit that it is unnecessary and unreasonably expensive to go through the process of employing each OCP under a separate application. Nonetheless, by the Motion, the Debtors, out of an abundance of caution, propose an efficient and appropriate procedure by which the Debtors may employ OCPs. This procedure calls for each OCP to file a declaration, and if there are no objections, to be employed and compensated in the ordinary course of business. Although not waived, no prepetition claims held by an OCP will be paid except at the same time and in the same manner as all other unsecured claims are paid, if allowed by the Court.

Capitalized terms used but not otherwise defined herein have the meanings ascribed to them in the Motion (as defined herein).
